The products of Ukraine listed below will be subject to 100 percent *ad valorem* duties, effective with respect to goods entered, or withdrawn from warehouse, for consumption on or after January 23, 2002. The product descriptions in this annex are for information purposes only; the descriptions are not intended to delimit in any way the scope of products subject to increased duties. Instead, the scope of this action under Section 301 is governed by the HTS nomenclature for the subheadings listed below. Issues regarding the classification of particular products would be decided by the U.S. Customs Service under its usual rules and procedures for product classification.
