CHAPTER EIGHT SAFEGUARDS

ARTICLE 8.1: APPLICATION OF A BILATERAL SAFEGUARD MEASURE

If as a result of the reduction or elimination of a customs duty under this Agreement, an originating good of the other Party is being imported into the territory of a Party in such increased quantities, in absolute terms or relative to domestic production, and under such conditions that the imports of such originating good from the other Party constitute a substantial cause of serious injury or threat thereof, to a domestic industry producing a like or directly competitive good, such Party may, during the transition period,:

- (a) suspend the further reduction of any rate of customs duty on the good provided for under this Agreement; or
- (b) increase the rate of customs duty on the good to a level not to exceed the lesser of
 - (i) the most-favoured-nation (MFN) applied rate of duty on the good in effect at the time the action is taken, and
 - (ii) the MFN applied rate of duty on the good in effect on the day immediately preceding the date of entry into force of this Agreement.

ARTICLE 8.2: CONDITIONS AND LIMITATIONS

The following conditions and limitations shall apply with regard to a measure described in Article ___.1:

- 1. A Party shall notify the other Party in writing upon initiation of an investigation described in paragraph 2 and shall consult with the other Party as far in advance of taking any such measure as practicable, with a view to reviewing the information arising from the investigation, exchanging views on the measure, and reaching an agreement on compensation as set out in Article ___.3
- 2. A Party shall take a measure only following an investigation by that Party's competent authorities in accordance with Articles 3 and 4.2(c) of the Safeguards Agreement; and to this end, Articles 3 and 4.2(c) of the Safeguards Agreement are incorporated into and made a part of this Agreement, *mutatis mutandis*;
- 3. In the investigation described in paragraph 2, a Party shall comply with the requirements of Article 4.2(a) of the Safeguards Agreement; and to this end, Article 4.2(a) is incorporated into and made a part of this Agreement, *mutatis mutandis*.
- 4. No measure may be maintained:

- (a) except to the extent and for such time as may be necessary to prevent or remedy serious injury and to facilitate adjustment;
- (b) for a period exceeding three years; or
- (c) beyond the expiration of the transition period, except with the consent of the Party against whose originating good the measure is taken.
- 5. No measure may be applied against the same good on which a measure has been taken under this Chapter.
- 6. Where the expected duration of the measure is over one year, the importing Party shall progressively liberalize it at regular intervals during the period of application.
- 7. Upon the termination of the measure, the rate of customs duty shall be the rate that would have been in effect but for the measure.

ARTICLE 8.3: COMPENSATION

The Party taking a measure described in Article __.1 shall provide to the other Party mutually agreed trade liberalizing compensation in the form of concessions having substantially equivalent trade effects or equivalent to the value of the additional duties expected to result from the measure. If the Parties are unable to agree on compensation within 30 days from the date the Party announces a decision to take the measure, the Party against whose good the measure is taken may take tariff action having trade effects substantially equivalent to the measure described in Article __.1. The Party taking the tariff action shall apply the action only for the minimum period necessary to achieve the substantially equivalent effects, and in any event, only while the measure under Article __.1 is being applied.

ARTICLE 8.4: GLOBAL SAFEGUARD MEASURES

Each Party retains its rights and obligations under Article XIX of GATT 1994 and the Safeguards Agreement. This Agreement does not confer any additional rights or obligations on the Parties with regard to global safeguard measures.

ARTICLE 8.5: DEFINITIONS

For purposes of this Chapter:

- (a) **domestic industry** means the producers as a whole of the like or directly competitive product operating in the territory of a Party, or those whose collective output of the like or directly competitive products constitutes a major proportion of the total domestic production of those products;
- (b) **global safeguard measure** means a measure applied under Article XIX of GATT 1994 and the Safeguards Agreement;

- (c) **serious injury** means a significant overall impairment in the position of a domestic industry;
- (d) **substantial cause** means a cause which is important and not less than any other cause.
- (e) **threat of serious injury** means serious injury that, on the basis of facts and not merely on allegation, conjecture, or remote possibility, is clearly imminent; and
- (f) **transition period** means the _____-year period following entry into force of this Agreement.
