#### Albania and the U.S. Generalized System of Preferences (GSP) Program How to Use GSP Duty-Free Benefits to Increase Albania's Exports March 2008

#### What is GSP?

The U.S. GSP program provides duty-free treatment for about 3,400 types of exports from Albania and 130 other developing countries. Least-developed beneficiaries are able to export another 1400 exports free of duty to the United States. The purpose of the GSP program is to give these exports a competitive edge in the U.S. market. U.S. companies and customers are especially interested in buying goods through the GSP program because the exports are not charged tariffs, upon entering the United States, which can range from two percent to seventeen percent of the items' cost. U.S. imports under GSP in 2007 from all beneficiary countries totaled \$30.8 billion.

Many items are eligible for GSP duty-free treatment. These include most manufactured goods; inputs used in manufacturing; jewelry; many types of carpets; certain agricultural and fishery products; and many types of chemicals, marble, and minerals. Not eligible for GSP duty-free treatment are certain textiles and apparel; watches; some footwear, handbags, and other leather items; luggage; most cloths and sheets for kitchen and bedroom use; and work gloves. The chart below shows the percentage of product types entering the United States under the GSP program in 2006.



#### **Albania's Use of GSP Preferences**

From January through October 2007, Albania was the 80th largest user of the GSP program. The trade value of U.S. imports from Albania that received GSP duty-free treatment was: \$103,700 in 2005, \$247,420 in 2006, and \$161,833 in the first ten months of 2007. Products imported from Albania under GSP in 2007 were diverse and included:

• Fixed vegetable fats and oils and their fractions, whether or not refined, not chemically modified (HTS 15159080, duties saved 3.2 percent)

- Sandstone, merely cut into blocks or slabs of a rectangular (including square) shape (HTS 25162020, duties saved 3 percent)
- Static converters (for example, rectifiers) (HTS 85044095, duties saved 1.5 percent)

In 2007, Albania utilized just 55 percent of potential GSP benefits. This means that just over half (\$161,833) of all GSP-eligible products (\$293,716) that entered the United States received GSP duty-free treatment. The remaining \$131,883 in U.S. imports from Albania were assessed duties of up to 11 percent unnecessarily.

In 2006, a higher percentage (71 percent) of all GSP-eligible U.S. imports from Albania were claimed and received duty-free treatment. For example, all 2006 exports to the United States of mineral waters and aerated waters, not containing added sugar or other sweetening matter nor flavored (HTS 22011000) entered the United States duty-free under the GSP program, while in the January to October 2007 period, only 71 percent of the U.S. imports of the same product did.

The rates at which U.S. importers claimed GSP duty-free treatment for eligible imports from Albania in 2006 and 2007 are well below the most current global GSP utilization rate average of 87.9 percent. It points to a significant need to provide outreach to producers and exporters in Albania, as well as to U.S. importers of Albanian products (e.g., the American Chamber of Commerce in Albania, or the U.S.- based Albanian American Trade & Development Association). The sharp drop in the claim of GSP benefits by U.S. importers between 2006 and 2007 is also of concern, despite overall U.S. imports of GSP-claimed goods increasing nearly nine percent thus far in 2007.

## How Can More Albanian Products Be Imported by the United States Free of Duty under GSP?

# **<u>1. Claim the GSP Savings</u>:** Albanian producers and exporters need to make sure that they mark U.S. customs entry form 7501 with an "A" before the product's tariff number to ensure GSP duty-free treatment (see page six).

GSP-eligible U.S. imports from Albania which did not receive duty-free treatment included (see pages nine and ten):

- Imitation jewelry (o/than toy jewelry & rope, curb, cable, chain, etc.), of base metal (whether or n/plated w/precious metal) (HTS 71171990) (MFN duty: 11 percent)
- Ceramic (other than porcelain, china, or earthenware) ornamental articles (HTS 69139050) (MFN duty: 6 percent)
- Parts and accessories of liquid crystal devices, and optical appliances and instruments (HTS 90139090) (MFN duty: 4.5 percent)
- Fixed vegetable fats and oils and their fractions, whether or not refined, not chemically modified (HTS 15159080, duties saved 3.2 percent)
- Parts of trailers and semi-trailers and vehicles, not mechanically propelled (HTS 87169050) (MFN duty: 3.1 percent)
- Plugs and sockets for making connections to or in electrical circuits, for a voltage not exceeding 1,000 volts (HTS 85366980) (MFN duty: 2.7 percent)
- Spices (HTS 09109960) (MFN duty: 1.9 percent)
- Mineral waters and aerated waters, not containing added sugar or other sweetening matter nor flavored (HTS 22011000) (MFN duty: 0.26 cents/liter)

#### 2. Export GSP-eligible textile and apparel items (see Attachment Three):

The United States imports a large amount of apparel and footwear items from Albania. This trade could potentially be expanded to include the following GSP items.

#### <u>In general:</u>

- 57025120: Floor coverings (hand-woven and not of pile construction) (4.3%)
- 57031020: Tufted hand-hooked carpets & other floor coverings of wool or fine animal hair (6%)
- 51161008: Sports gloves, mitts, and mittens (2.8%)
- 65069900: Headgear of materials other than rubber, plastics, or furskins, whether or not lined or trimmed
- 66019900: Umbrellas, other than garden or similar umbrellas, w/out a telescopic shaft (8.2%)
- 56089023: Hammocks, of cotton (14.1%)
- 63079085: Wall banners, of man-made fibers (5.8%)
- 63079098: National flags and other made-up articles of textile materials (7%)
- 64059020: Disposable footwear, designed for one-time use (3.8%)
- 64061072: Uppers for footwear, of cotton, w/external surface area less than 50% textile materials (11.2%)
- 64061085: Uppers for footwear, of materials, w/external surface area less than 50% textile materials (4.5%)

#### 3. Export Products Duty-Free to the United States that are Currently Exported Elsewhere.

Albania exports certain goods to other countries, but not the United States in large amounts. Many of these items are eligible for GSP treatment upon entering the United States, such as: some footwear uppers and upper parts except stiffeners; ferrochromium over 4 percent carbon; and locks except motor vehicle or furniture, of base metal. Exports of parts of electric motors under 18.65 W, other than commutators, stators or rotors, can alone save duties of up to 6.5 percent under GSP, offering a competitive advantage in the U.S. market.

#### 4. Export Home Décor Items and Handicrafts

Many types of handicraft exports to the United States are duty-free under GSP or from all countries. The Albanian government, the Albanian Centre for International Trade, women's groups, and non-governmental organizations could work with artisans to export Albanian home décor and handcrafts, including filigree, wood carvings, copper engraved vases, alabaster, bone, ceramic, horn, and rugs, and leather products. The following items can enter the United States free of duty:

gemstones and jewelry, including imitation	fur head coverings
traditional games	wind, string, and drum musical instruments
paintings, sculpture, and wall hangings	wood picture frames
many types of carpets, kilims, and rugs	various types of hats
wooden statuettes, boxes, and other wood items	certain baskets and handbags of bamboo, rattan,
walking sticks	palm leaf and vegetable material

#### How does an import receive GSP duty-free treatment?

#### A GSP-eligible import must meet the following requirements:

- be included on the list of GSP-eligible articles;
- be imported into the United States directly from Albania or pass through another country under a bill of lading
- be the growth, product, or manufacture of Albania;

- if some materials used to make the product are imported into Albania, the cost of the Albanian materials plus the cost of processing must equal at least 35 percent of the product's sales price;
  - imported materials can count toward that 35 percent only if the imported materials are "substantially transformed" and then used to produce or manufacture the export
  - "substantially transformed" means that the imported items go through at least two types of changes in form from when they were first imported
  - <u>MOST IMPORTANTLY</u>: The importer must request duty-free treatment under GSP by placing an "A," in front of the Harmonized Tariff Schedule of the United States number that identifies the imported article on U.S. Customs Entry Form 7501 (attached).

#### What documents are needed to ensure GSP duty-free treatment?

- For agricultural exports:
  - 1. Producer's statement verifying which town and farm the product is grown on;
  - 2. Description of product and quantity;
  - 3. Dated invoices for costs incurred.
- To verify the 35 percent rule of origin rule:
  - 1. Dated invoices for materials used to produce the good, showing from where the materials came;
- 2. Description of product and quantity.
- If processing operations are involved:
  - 1. Description of processing and location;
  - 2. Documentation of the direct costs of processing operations.
- NOTE: The importer must keep all documents for at least 5 years.
