

International Trade in Services Benefits Georgia's Companies and Workers

IMPORTANCE OF SERVICES TO THE OVERALL U.S. ECONOMY

- **The United States is the world's leading services exporting nation.** International services markets offer huge opportunities for U.S. firms and their employees, accounting today for nearly one-third of total U.S. exports. Total elimination of global barriers to trade in services could raise U.S. annual income by over \$450 billion or \$6,830 per family of four.
- **U.S. services exports have doubled over the past 10 years.** The United States recorded a \$66 billion surplus on exports totaling \$381 billion in 2005. This surplus was 22 percent higher than in 2004. Sales through U.S. services companies operating abroad measured \$477 billion in 2003. These international transactions support high-paying jobs across the United States.

IMPORTANCE OF SERVICES TO THE GEORGIA ECONOMY

- The services sector represents 71 percent of sales by Georgia businesses, employs 78 percent of the workforce, and pays 77 percent of the state's \$106 billion in wages.¹
- Services exporters from Georgia employed 43,000 people and generated \$971 million in export revenues in 2002.² For example:
 - Professional, scientific and technical industry exporters from Georgia employed 11,400 people and generated \$307 million in export revenues.
 - Telecommunications exporters from Georgia employed 15,200 people and generated \$390 million in export revenues.
 - Publishing industry exporters from Georgia employed 4,900 people and generated \$102 million in export revenues.
- Affiliates of foreign services companies are part of this success. In 2003, companies such as Nestlé (Swiss), Deutsche Telekom (German), and Ikea (Swedish) had over \$4.6 billion invested in property, plants, and equipment (PPE) in Georgia and supported over 44,000 jobs.³
