Initial List of Environmental Goods

Submission by the United States

Paragraph 31(iii)

The following communication, dated 30 June 2005, is being circulated at the request of the Delegation of the <u>United States</u>.

- 1. The United States welcomes the progress made to date on environmental goods in the Committee on Trade and Environment in Special Session (CTESS). Subparagraph 31(iii) appears to hold the greatest potential in Paragraph 31 for meaningful and substantive results before Trade Ministers meet in Hong Kong. With a view to contributing to the momentum of these negotiations and to moving the discussions forward in a concrete, pragmatic manner, the United States is proposing an initial list of environmental goods in the attached annex. The United States developed this list following consultations with U.S. stakeholders, advisory committees, interested agencies, and the U.S. Congress.
- 2. The U.S. list is based on a practical, bottom-up approach to identifying environmental goods, an approach which the United States outlined in some detail in a previous submission (TN/TE/W/34). This approach focuses on end-use criteria (e.g., goods which are used to clean the environment or to contain or prevent pollution), and does not rely on product distinctions based on process or production methods (PPM-based criteria) or end-use certificates.
- 3. While the U.S. list is based on the APEC approach, it goes beyond the APEC list to cover an additional 46 products (156 products total), most of which fall into the renewable energy or natural resource protection categories. The specific environmental category of each good is identified in the annex to this paper. For purposes of transparency, the United States has included import and tariff data for all goods identified, and indicated cases where a good is also included on another list, including the list of another Member (at the HS 6 digit level).
- 4. The United States offers this initial list for the consideration of Members in an effort to move the discussions forward, but may at a later point add to this list, or delete from it, during the course of our discussions on environmental goods. The United States looks forward to working with Members in moving closer to the goal of an agreed list of environmental goods in the coming months and urges other delegations to fully engage in these important discussions, which hold potential benefits for trade, environment and development for all WTO Members. We also agree that the environmental industry is continually evolving and that the CTESS should give consideration to how best to ensure that an agreed list of environmental goods reflects new technologies.
- 5. Given the nature of this issue and U.S. practice with previous papers submitted under Paragraph 31(iii), this paper is being submitted to both the CTESS and the Non-Agricultural Market Access Negotiating Group (NAMA).

Key to Reading Annex A: United States Initial Environmental Goods List

Columns A, B, C and D: HS 6, HS 6 Description, Ex, and Additional Product Description within HS 6 Category

- 1. Proposed environmental products are listed in Harmonized System (HS) categories at the 6 digit level. In certain cases, the entire HS 6 category is not exclusively used for an environmental purpose, and only part of the category is intended as an environmental good. For those products an additional product description is given to help identify the environmental good within the 6 digit category. For example, one proposed product is pumps for liquids (HS 841360); however, only "submersible mixer pumps to circulate water in waste water treatment process; sewage pumps, screw type" are intended as environmental goods, not all pumps for liquids. These additional product descriptions are coded with an "ex" as they could be incorporated at the narrower, national tariff line level (i.e., the eight- or nine-digit level, as appropriate).
- 2. For those products that do not contain an additional product description or an "ex," we propose that the entire 6 digit category be considered for liberalization because the product is an important element of an environmental technology.

Column E: Environmental Category

3. This column conveys the relevance of each product to environmental protection. We have used the following environmental categories, most of which have been used previously by other WTO Members (e.g., Canada, Korea, New Zealand). We have also added one new category, natural resources protection.

APC= Air Pollution Control

RS = Recycling Systems

S/H = Solid/Hazardous Waste Management

H/E = Heat/Energy Management

PWT = Potable Water Treatment

WWM = Waste Water Management

M/A = Environmental Monitoring, Analysis and Assessment

R/C = Remediation/Clean-up of Soil and Water

NV = Noise/Vibration Abatement

REP = Renewable Energy Plant

EPP = Environmentally Preferable Products based on end-use or disposal characteristics

NR = Natural Resources Protection

Column F: Average MFN Tariff Rate (2001)

4. The tariff rate is based on the 2001 MFN rate. The U.S. environmental goods list was developed at the HS 6 digit level and the tariff rate is a simple average of all the national line tariffs that comprise each HS 6 digit category. The U.S. tariff rate is for 2001 because 2001 is the base year tariff currently used in the WTO Non-Agricultural Market Access Negotiations.

Column G: U.S. U.S. Imports from the World (Average 1999-2001)

5. The source of import data is the United States International Trade Commission and the data reported is the average value of imports from years 1999 to 2001. This is the reference period with which Members currently submit trade data to the Non-Agricultural Market Access Negotiating

Committee. The import data is provided at the HS 6 digit level which may be broader than the actual trade for the proposed environmental good.

Column H: Overlap with Other Members' Proposed Lists (at HS 6 level)

6. For purposes of transparency, this column indicates if the U.S. proposed product is included on another WTO Member's proposed environmental goods list, as of the date of this submission to the CTESS. This column indicates overlap *only* at the HS 6 digit level. Products without any overlap are additional products proposed by U.S. industry and other stakeholders, advisory committees, or interested U.S. government agencies.

Column I: Overlap with Regional and International Organizations' Lists (at HS 6 level)

7. For purposes of transparency, this column indicates if the U.S. proposed product is included on the environmental goods list of an organization such as APEC, OECD, or UNCTAD, as of the date of this proposal to the CTESS. This column indicates overlap *only* at the HS 6 digit level. Products without any overlap are additional products proposed by U.S. industry and other stakeholders, advisory committees, or interested U.S. government agencies.
