Indo-Pacific Economic Framework Treatment of Documents Related to Negotiations

The United States and the Republic of Fiji have jointly decided on the following approach for the protection and handling of documents and information exchanged in the context of negotiations on the trade pillar of the Indo-Pacific Economic Framework:

- Proposals of each participant, accompanying explanatory material, emails, and other substantive information exchanged in the context of the negotiations or regarding implementation of the agreement are provided, and will be held, in confidence unless otherwise jointly decided. Such information may be provided only to (1) government officials or (2) persons outside government who participate in the government's domestic consultation process and who have a need to review or be advised of certain information. Anyone given access to this information will be informed that they cannot share the information with people who are not authorized to see the information. The documents and information will be held in confidence for five years after any instrument enters into force, or five years after the close of negotiations related to such instrument. These restrictions will not apply to a participant's own information, which the participant may disclose, provided that any reference to positions of the other participant or to agreed text is not included in the disclosure.
- While documents and information associated with the above referenced discussions are confidential, this information may be mailed, emailed, faxed, or discussed over unsecured lines with any of the individuals identified in the preceding paragraphs (i.e., government officials and persons outside government who participate in a domestic consultation process). Documents and information may be stored in a locked file cabinet or within a secured building; that is, this information does not need to be stored in safes. This information can be created and stored on unclassified computer systems and password-protected websites.
- Documents created pursuant to, or as a result of, the above referenced discussions will be
 marked in a manner that makes clear that the documents, regardless of their physical form
 or characteristics, and the information contained in those documents, will be held in
 confidence. To that end, the United States will mark documents as "Indo-Pacific Economic
 Framework CONFIDENTIAL, Modified Handling Authorized (C/FGI-MOD)" and the
 Republic of Fiji will mark documents in accordance with its policy and practice.
 Documents that are shared will contain both markings.

The policy underlying this approach is to maintain the confidentiality of documents and information, while at the same time allowing the participants to develop their positions and communicate internally and with each other and engage with their public, as they consider appropriate, in developing and communicating their own positions.
